### 4. FIRST AID MEASURES

#### Description of necessary measures

**Inhalation:** Remove from exposure area to fresh air. Treat symptomatically and supportively. If any symptoms appear, get medical attention.

**Skin contact:** Rinse affected area with large amounts of water until no evidence of product remains. Discontinue exposure. Get medical attention if irritation persists.

**Eye contact:** Immediately rinse eyes with plenty of water for at least 15 minutes while holding eyelids open. Get medical attention if pain or irritation develops.

**Ingestion:** Dilution by rinsing the mouth and giving water or milk to drink is generally recommended. Contact physician or local poison control center.

#### Most important symptoms and effects, both acute and delayed

After eye contact: Moderate to strong irritation of the eyes (redness, swelling, burning, watering eyes), the occurrence of these symptoms may be delayed. After skin contact: Moderate to strong irritation of the skin (redness, swelling, burning), severe burns also possible. After Ingestion: Ingestion may cause pain, burning, swelling and redness in the mouth and throat. Nausea and vomiting may occur. After inhalation: Dust may cause mucous membrane irritation with coughing and shortness of breath.

#### Indication of any immediate medical attention and special treatment needed

After eye contact: Rinse eyes immediately with plenty of water, occasionally lifting upper and lower lids, until no evidence of product remains.

After skin contact: Rinse affected area with large amounts of water until no evidence of product remains. After ingestion: Dilution by rinsing the mouth and giving a glass of water to drink is generally recommended. After inhalation: Remove from exposure area to fresh air. ### 5. FIRE FIGHTING MEASURES

#### Specific hazards arising from the chemical

Thermal decomposition products may include toxic oxides of sodium and boron.

#### Special protective equipment and precautions for fire-fighters

In case of fire, wear a full-face positive-pressure self-contained breathing apparatus and protective suit. Shut off all ignition sources. Apply cooling water to sides of containers that are exposed to flames until well after fire is out. Isolate area. Keep unnecessary personnel away. Avoid breathing vapors, keep upwind.

### 6. ACCIDENTAL RELEASE MEASURES

#### Personal precautions, protective equipment and emergency procedures
