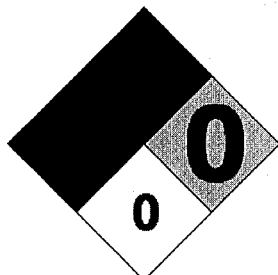

### SECTION 5 : Firefighting measures

#### Extinguishing media
