2. Hazards Identification

HAZARDS OVERVIEW: UNDER NORMAL USE CONDITIONS, SUCH AS BRUSH, PAD, OR ROLLER APPLICATION, THIS PRODUCT IS NOT EXPECTED TO CAUSE ADVERSE HEALTH EFFECTS. This product does contain crystalline silica, a material that can cause lung cancer or silicosis if inhaled. During brush, pad, or roller application the crystalline silica is contained in a liquid matrix and is unlikely to be inhaled. The risk of lung cancer or silicosis depends on duration and level of exposure from sanding dry surfaces or spray mist. When sanding or spraying product use (NIOSH/MSHA approved) respiratory protection (See Section 8).

4. First-aid Measures

Practical Experiences

EFFECT OF OVEREXPOSURE - INHALATION: This product contains crystalline silica, which is considered a hazard by inhalation.

Inhalation may cause irritation to the respiratory tract (nose, mouth, mucous membranes).

EFFECT OF OVEREXPOSURE - SKIN CONTACT: PROLONGED OR REPEATED CONTACT MAY CAUSE IRRITATION.

EFFECT OF OVEREXPOSURE - EYE CONTACT: MILD EYE IRRITANT.

EFFECT OF OVEREXPOSURE - INGESTION: May be harmful if swallowed. May cause gastrointestinal disturbance.

EFFECT OF OVEREXPOSURE - CHRONIC HAZARDS: Crystalline silica is known to cause silicosis, a noncancerous lung disease. Exposure is by route of inhalation. If material is in a liquid matrix it is unlikely to be inhaled.

CARCINOGENICITY: Crystalline silica has been classified by IARC and NTP as a carcinogen for humans (Group 1) from lab animal studies. Inhalation of crystalline silica can cause lung cancer. IARC lists Titanium Dioxide as a possible human carcinogen (Group 2B) by route of inhalation. Under normal use conditions, such as brush, pad, or roller application, carcinogenic materials are suspended in a liquid matrix and are unlikely to be inhaled. Risk of cancer depends on duration and level of exposure from sanding surfaces or spray mist. When sanding or spraying product use (NIOSH/MSHA approved) respiratory protection.
