

SECTION 2 — HAZARDS IDENTIFICATION

Flinn Suggested Chemical Storage Pattern: Organic #2. Store with alcohols, glycols, amines and amides. Store in a cool, dry place. Store in a Flinn Chem-Saf™ bag, and lock up in a poison cabinet.
