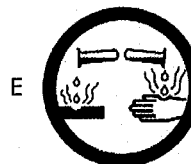

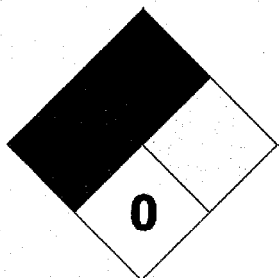

### SECTION 5 : Firefighting measures

If necessary, use trained response staff/contractor. Remove from all sources of ignition. Soak with inert material. Use spark-proof tools and explosion-proof equipment. Always obey local regulations.

### SECTION 7 : Handling and storage

#### Precautions for safe handling:

Prevent formation of aerosols. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. If in a laboratory setting, follow Chemical Hygiene Plan. Use only in well ventilated areas. Avoid splashes or spray in enclosed areas. Wash hands after handling. Avoid contact with skin and eyes.

**Appropriate Engineering controls:** Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use/handling.
